Registering for the Trial

Entries will not be accepted without signatures and payment. Owners are responsible for entry errors. No refunds after May 1, 2019. No refunds for natural disasters/Acts of God/extreme emergencies, except at the discretion of the Chair. Your reservation will be confirmed by email. Entries without payment do not constitute a valid entry.

Day of Trial

Registration opens at 7:30am. Instinct begins at 8:30 AM, both days.

“Day of” registration ends 15 min prior to the start of your class- please come early.

Trials will run concurrently each day, and Classes will run back to back-

Instinct, Novice, Novice, Open, Open in Ring 1; followed by Senior, Senior, Master, Master, Crazy 8s, Crazy 8s in Ring 2.

Entries: Registration Opens Friday, 3/15/2019, Closes Mon 4/15/2019. Late and Day of Trial Entries accepted.

Entry Fees:

Instinct \$15/\$18/\$20 Day of Trial,
Novice/Open \$20/\$23/\$25 Day Of Trial,
Senior, Master, Crazy 8's \$25/\$28/\$30 Day of Trial

Running Order:

The running order will be posted on the dry erase board near ringside. All requests for running order changes must be approved by the Trial Secretary.

Both Rings will be Indoors on Concrete/Straw.

Ribbons awarded for qualifying scores in all classes; Rosettes awarded for height placement 1st through 3rd; Rosettes awarded for new titles in Novice, Open, Senior, Master & Crazy 8's

General Guidelines

- All participants should check in with the secretary upon arrival.
- Bitches in Season ("BIS") will run at the end of the class. BIS must wear panties; notify the Secretary prior to the trials, so we can provide you with a separate area to crate and to potty, and to arrange for separate blinds. Identify yourself to the Chair, Secretary, and the Judge at General briefing. If you need to withdraw your dog due to a contagious illness, or withdraw your BIS after May 1, contact the Secretary to be issued a voucher for a future Link Canine Coaching/Smartypaws trial.
- We reserve the right to change running orders as needed to keep the trial running smoothly.
- This event is open to all dogs 6 months of age and older.
- No refunds will be made for cancellations or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee
- Exhibitors are responsible for complete accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and /or guests repeatedly engages in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on the leash at all times except when in the ring, NO FLEXI LEADS allowed on the property.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and potty your dog in the designated potty area and pick up after your dog.
- PLEASE STAY ON THE PROPERTY. Do not take your dog off of the property to avoid disturbing the neighbors.
- A separate entry blank must be completed for each dog entered. Please use care in clearly indicating which date(s) of entry.
- Exhibitors should follow their veterinarians; Recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- No entry fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, extreme weather conditions, or any other cause beyond the control of the event committee.

- Please bring your own chairs, water for your dog, kennels are highly recommended.
- Drinks and snacks will be available on site. Lunch will also be available.
- No telephone, fax, or credit card payments (except via PayPal) will be accepted.
- No alcoholic beverages or smoking / vaping are allowed at the event site.
- Please respect the grounds and clean up after yourself and your dogs to maintain the premises in a clean and tidy condition!
- No dog to dog interaction; assume that every dog needs space
- No dog to dog aggression or dog to human aggression will be allowed; this will be cause for exclusion from the event and forfeit of entry fees
- Please keep your dog at least 10 feet from the ring and the blind, unless entering or exiting either the ring or blind, and do not block pathways between the two. Dogs are excited to be heading to the ring to start hunting; avoid unnecessary confrontations.
- You may not run a dog that is sick, lame, injured or blind.
- **Good sportsmanship always, and humane treatment of dogs always!**

Around the Venue

Directions to the Venue

From Utah

On entering Las Vegas, follow I-15 South to W Russell Rd (Exit 36). Continue on Russell Rd and the destination will be on the RIGHT.

From Arizona

Take US-93 North, and continue onto I-11. Merge onto I-215 West. Take Exit 13 for Decatur Blvd. Continue on Decatur Blvd for about 1 mile, and turn right onto W. Russell Rd. Destination will be on the RIGHT.

From California

Take I-15 North to Russell Rd/Frank Sinatra Dr (Exit 35). Follow signs for Russell Rd. Continue on Russell Rd, and the destination will be on the RIGHT.

From Reno

Take US-95 South and then follow signs to merge onto I-15 South/Los Angeles. Take Exit 36 for Russell Rd. Continue on Russell Rd and the destination will be on the RIGHT.
