The facility will open at 8:15am, check-ins will start at 8:30am, please check -in at least 30 minutes prior to your run. General briefing will be held at 8:55am. This Fun Test will start with the first dog entering the ring at 9am on Saturday March 18th and March 19th. Facility will close when the events are completed. March 18th will run in this order: Instinct, Novice, & Open. March 19th will run in this order: Senior, Master, & Line Drive. The Fun Test does not have "Qualifying" runs, there are only placement (1st- 4th) ribbons for the Fun Test. No title points accumulated during this event. Classes are consecutive.

Any dog may enter this Fun Test, no Barn Hunt Association Number required.

This location is an outdoor facility at a private residence, with limited parking, no overnight parking. No wheelchair accessibility. Please park in the designated areas, we will include instructions in the confirmation email. We will have parking spots designated for volunteers. When you arrive, please go through the 2 gates (gravel driveway) into the backyard.

The ring is outdoors with a dirt ground that is covered with hay.

Blinds will be set up for the trial runs, and the Line Drive event. Blinds will be 20 feet from the ring, and the 2nd blind will be set up 20 feet from the Line Drive area. The blinds will be 10'x10' in size to accommodate 4 dogs and handlers. Chairs will be provided in the blind.
