Entry Limits:

This trial is limited to 500 runs per judge/day. In the event we exceed capacity, entries will be prioritized by most runs, then first received.

Move ups:

Move ups will be accepted from day to day.

Day of show Entries:

(\$5.00 administrative fee. One time processing fee.)

We encourage exhibitors to pre-enter.

For Exhibition Only:

(FEO) runs will be accepted.

Dogs must be at least 18mos and jump a minimum of 4" lower than their standard jump height.

Refunds:

Full refunds will be issued for cancellations prior to closing date.

Cancellations after the closing date for bitches in season or injured dogs may be subject to an administrative fee. There will be no refunds in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

Entry fees will be refunded if the trial must be cancelled.

No entry fees will be returned if the trial proceeds and cannot be completed by reason of riots, civil disturbances, fire, an act of God, a public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Note: NADAC's default is to hand the leash to exhibitors at the end of the run. Exhibitors may ask for it to be placed on the designated marker, they may also carry leash stowed in pocket or wrapped around shoulders. Just be sure to avoid dangling ends and stow securely before you cross the start line. A leash buddy is also acceptable.

Awards and Ribbons:

Ribbons will be available for all qualifying runs and first through fourth place in all classes except for Chances. Since Chances is a pass/fail game, placement ribbons are not given. We have Ribbons available for those finishing a New Title. Let the Trial Secretary know what title your dog earned, and we'll be happy to get one for you!

Please let us know if your dog may earn a NATCH and/or V-NATCH. We love to be prepared and help you celebrate!

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <https://www.nadac.com/register-your-dog/>
- A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (zip-lock bag is acceptable) in your pocket during your run but you cannot indicate to the dog it is there. All handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both the exhibitor and the owner of the entered dog. In consideration of acceptance of this entry:

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
 - 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
 - 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
 - 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
 - 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), **Smarty Paws Canine Coaching** (including its officers, directors, members, and event organizing committee), and **Smarty Paws Canine Coaching LLC.** (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing, hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

Release and Waiver of Liability

This Release and Waiver of Liability (the "Release") is agreed to and executed by the entrant into the Smarty Paws Canine Coaching LLC NADAC agility trial in favor of Smarty Paws Canine Coaching LLC (hereinafter "Smarty Paws") and The North American Dog Agility Council, LLC, (hereinafter "NADAC"), its directors, officers, employees, agents, representatives, volunteers, members, successors, and assigns, (collectively, "Smarty Paws" and "NADAC"). Handler and/or Owner intends to participate in Smarty Paws upcoming NADAC agility trial to which the premium is attached and in consideration of the acceptance of this entry and of the holding of this NADAC event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies/bars, enters this Release and Waiver in contemplation thereof.

1. Waiver and Release. Handler and/or Owner does hereby, voluntarily, and without duress, execute this Release. Handler and/or Owner does hereby release and forever discharge NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, and any NADAC approved judge judging at this event, and other participants at the event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of any dog while in or about the event premises or grounds or near any entrance thereto, from any and all actions, causes of action, suits, debts, liabilities, claims, and demands of whatever kind or nature, either in law or in equity, which have arisen now or may hereafter arise from Handler and/or Owner's participation in the NADAC events. Handler and/or Owner understands that this Release discharges NADAC and Smarty Paws from any liability or claim that Handler and/or Owner may have against NADAC or Smarty Paws with respect to any bodily injury, personal injury, illness, death, property damage, or any other damages that may result from Handler and/or Owner's participation in Smarty Paws events.

2. Assumption of Risk. Handler and/or Owner acknowledges and agree that dog bites or other injuries to humans and other dogs do occur, and that all dogs can carry and transmit diseases, including diseases that can be transferred from dogs to humans. Handler and/or Owner understand that NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the

event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, will not be responsible for any damage any dog may inflict on any person, another dog, any property, or for the transmission or transfer of any disease or parasite to other dogs or people, and no attempt will be made by Handler and/or Owner, or anyone on the behalf of the Handler and/or Owner, to hold NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, responsible for such damages. Handler and/or Owner hereby expressly and specifically assumes the risk of injury or harm resulting from Handler and/or Owner's participation in Smarty Paws events.

3. Indemnification. Handler and/or Owner agree to indemnify and hold NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, harmless from any and all damages, loss, cost, or liability (including reasonable legal fees and the cost of enforcing this indemnity) arising out of or in any way resulting from Handler and/or Owner's participation in Smarty Paws events, specifically including any and all attorney's fees incurred by NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, and other participants at the event, incurred in enforcing this Release.

4. No Representations. Handler and/or Owner acknowledges and agree that NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, make no representations with respect to any dogs that Handler and/or Owner may interact with while participating in Smarty Paws events.

5. Insurance. Handler and/or Owner understands that NADAC, Smarty Paws, the event-giving club, association or other host, its members, directors, volunteers, officers, agents, trial secretary, trial chair, owner and/or lessor of the premises hosting the event, any provider of services for the event, any employees and volunteers of the aforementioned parties, any NADAC approved judge judging at this event, do not carry or maintain health, medical, worker's compensation, automobile, or disability insurance coverage for any Handler and/or Owner. Handler and/or Owner is solely responsible for his/her own care and coverage, should any be desired or needed. Each Handler and/or Owner is expected and encouraged to make arrangements for appropriate insurance coverage prior to beginning participation in the Smarty Paws events.

6. Photographic Release. Handler and/or Owner agree that NADAC and/or Smarty Paws may use images and recordings, whether audio or visual or both, of Handler and/or Owner taken during or in connection with Smarty Paws events as it sees fit in its sole discretion to benefit and promote Smarty Paws and/or NADAC and Handler and/or Owner does not expect monetary compensation, remuneration, or a fee of any kind in exchange for allowing NADAC and/or Smarty Paws to use such images and recordings. Handler and/or Owner does hereby grant and convey unto NADAC and Smarty Paws all right, title, and interest in any and all photographic images and video and audio recording made by NADAC and/or Smarty Paws during Smarty Paws events, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings and Handler and/or Owner acknowledges and agree that all artistic control is in the hands of NADAC and/or Smarty Paws. 8. Signature Binding. Handler and/or Owner expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that this Release shall be governed by and interpreted in accordance with the laws of the State of California without regard to any conflicts of law provisions. Handler and/or Owner agree that if any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable. This document may be

transmitted by facsimile, email or similar method, and copies of this document may be relied upon and shall serve as originals. Handler and/or Owner is fully informed as to the nature of this release and Handler and/or Owner hereby represents that he or she has the power and ability to so grant this release. Handler and/or Owner understands that if Handler and/or Owner is approved to participate in Smarty Paws events that this Release shall apply to any and all Programs in which Handler and/or Owner participates.

Very Important – Agility exhibitors with their dogs must not cross into the area marked for the equestrian event. Violators will be expelled from the agility event with no refunds. No Exceptions. This policy will be strictly enforced to ensure we don't lose our access to the facility.
